

YumaBench Beta Agreement

YUMAWORKS' BETA TEST AGREEMENT

By clicking "I have read, understand and agree to the terms of the YumaBench Beta Requirements Policy", you, the customer identified from the form to accept this agreement ("Customer"), agree to be bound by the terms and conditions of this YUMAWORKS' BETA TEST AGREEMENT ("Agreement") between the Customer and YumaWorks Inc. ("YumaWorks") as of the date of clicking acceptance of this agreement.

- 1. License Grant.** Subject to the terms and conditions hereof, YumaWorks grants to Customer a limited non-exclusive, nontransferable, revocable license to use the YumaWorks' software YumaBench ("Software") in object code format solely for the purpose of Customer's internal evaluation of the Software and not for general commercial use.
- 2. No Services.** YumaWorks shall be under no obligation to provide Customer with any services. YumaWorks will provide the Software via electronic delivery. Customer will be responsible for installing the Software. YumaWorks may provide reasonable support for the Software.
- 3. Termination.** The licenses granted hereunder terminate on expiration of the BETA Test Period. Either party may terminate this Agreement upon written notice to the other party at any time. Within five days after termination Customer will delete the Software and all copies thereof. Sections 2 through 8 shall survive termination of this Agreement.
- 4. Proprietary Rights; Confidentiality; Restrictions.** Customer acknowledges that the Software contains confidential information and trade secrets of YumaWorks and its licensors. Customer will not: distribute, sell, sublicense or otherwise transfer or make available the Software or any portion thereof to any third party; remove from view any copyright legend, trademark or confidentiality notice appearing on the Software or Software output; modify, adapt, translate, reverse engineer, decompile or derive the source code for the Software, or authorize a third party to do any of the foregoing. Customer will not use the Software or any documentation provided therewith for any purpose other than Customer's internal evaluation and the provision of feedback to YumaWorks, and not to disclose to any third party without the prior written approval of YumaWorks, the Software, its features, feedback (as defined in Section 8) or the results of any performance or functional evaluation or test of the Software (the "Confidential Information"). Customer will use no less than all reasonable efforts to protect the Confidential Information from unauthorized use or disclosure. YumaWorks and its licensors reserve all rights and licenses in and to the Software not expressly granted to Customer hereunder.
- 5. Warranty.** THE SOFTWARE IS PROVIDED "AS-IS." YUMAWORKS DISCLAIMS ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING ANY WARRANTY OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE OR NONINFRINGEMENT.
- 6. Acknowledgment of Beta Software.** Customer acknowledges and agrees that: (a) the Software is not an official product and has not been commercially released for sale by YumaWorks; (b) the Software may contain errors, design flaws or other problems; (c) the information obtained using the Software may not be accurate and may result in unexpected results, loss of data or communications; (d) YumaWorks is under no obligation to release a commercial version of the Software; and (e) YumaWorks has the right unilaterally to abandon development of the Software, at any time and without any obligation or liability to Customer. Customer acknowledges and agrees that it should not rely on the Software for any reason.
- 7. Limitation of Liability.** EXCEPT AS OTHERWISE REQUIRED BY LAW, THE LIABILITY OF YUMAWORKS AND ITS LICENSORS TO CUSTOMER OR ANY THIRD PARTY ARISING OUT OF OR IN CONNECTION WITH THIS AGREEMENT OR THE USE OF THE SOFTWARE, OR FOR ANY ERROR OR DEFECT IN THE SOFTWARE, OR FOR THE PROVISION OF TECHNICAL SUPPORT INSTALLATION, TRAINING OR OTHER SERVICES IN CONNECTION THEREWITH, HOWEVER CAUSED, AND ON ANY THEORY OF LIABILITY, INCLUDING CONTRACT, STRICT LIABILITY, NEGLIGENCE OR OTHER TORT, SHALL BE LIMITED TO DIRECT DAMAGES NOT TO EXCEED ANY FEES PAID TO YUMAWORKS HEREUNDER. IN NO EVENT WILL YUMAWORKS OR ITS LICENSORS BE LIABLE FOR ANY INDIRECT, INCIDENTAL, SPECIAL, PUNITIVE OR CONSEQUENTIAL DAMAGES, INCLUDING DAMAGES FOR LOSS OF PROFITS, BUSINESS, REVENUE, DATA OR DATA USE, EVEN IF ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. THESE LIMITATIONS WILL APPLY NOTWITHSTANDING THE FAILURE OF THE ESSENTIAL PURPOSE OF ANY REMEDY.
- 8. Feedback.** Customer will provide reasonable feedback to YumaWorks concerning the features and functionality of the Software. If Customer provides feedback to YumaWorks, all such feedback will be the sole and exclusive property of YumaWorks. Customer hereby irrevocably transfers and assigns to YumaWorks and agrees to irrevocably assign and transfer to YumaWorks all of Customer's right, title, and interest in and to all feedback including all intellectual property rights therein (collectively, "Intellectual Property Rights"). Customer will not earn or acquire any rights or licenses in the Software or in any YumaWorks Intellectual Property Rights on account of this Agreement or Customer's performance under this Agreement, even if YumaWorks incorporates any feedback into the Software.
